## Information Collection and Use

## Log Data

We want to inform you that whenever you use our Service, in a case of an error in the app we collect data and information (through third party products) on your phone called Log Data. This Log Data may include information such as your device Internet Protocol ("IP") address, device name, operating system version, the configuration of the app when utilizing our Service, the time and date of your use of the Service, and other statistics.

## Activity Data

When you are signed in as a Subscriber, all of your activity is recorded within the app locally and backed up on our CoreX Cloud servers ("CLOUD"). This activity includes but is not limited to: client profiles, exercise recordings, and device settings. If you use the app while signed in but without internet access, all stored data will be uploaded to the Cloud the next time you open the app and are connected to the internet. In the app's Settings, you may choose whether to allow us to AGGREGATE your data, which means you give us permission to strip any and all personal identifying information and then analyze your data with that of other users for the purpose of providing additional features in the app in the future.

## Cookies

Cookies are files with a small amount of data that are commonly used as anonymous unique identifiers. These are sent to your browser from the websites that you visit and are stored on your device's internal memory.
